Each concessionaire is required to have a **Certificate of Insurance** showing a Comprehensive General Liability policy and Standard **Colorado Worker's Compensation**.

Each concessionaire is required to complete the **City of Grand Junction vendor qualification approval process** no later than July 7, 2022.

Each vendor is required to have a special events license from the Colorado Department of Revenue. You can apply online at <https://tax.colorado.gov/file-special-event-sales-tax-online>.

**Deposit: There is a refundable deposit of \$125 due at the time of the application. Deposits will only be refunded if the vendors meet all requirements stated in the 2022 Mesa County Fair Information and Regulations brochure.**

**Rates: are determined by the space they require.**

- **20 x 30" booths are \$700**
- **15' x 35' booths are \$500**
- **10' x 10' booths are \$150/ 10' x 10' Food booths are \$300**

**Booth spaces include electrical. If you have special electrical requirements there could be an additional charge.**

**\*Food/beverage vendors can get a \$100 discount by not using Styrofoam and only recyclable or reusable products please see attached flyer for details\***

There are a limited number of RV spaces available for a fee of \$32 for a full hook up, \$27 for a hook up with water and electric, and \$16 for a hook up with electric only.
